- E) Overhead service requests

**GFCI PROTECTION**  
**NEC CODE , Dept of Labor & Industries and all City Jurisdictions Require GFCI protection. Exhibitors must provide GFCI protection for electrical features with water including hot tubs, sinks fountains, etc. Hollywood Lights has a limited supply of GFCI protection available for rent.**

### Rental Information:

1. Material and equipment provided by this order shall be and remain the property of Hollywood Lights Inc. and shall be removed ONLY by Hollywood Lights personnel at the close of the show.
2. Outlets are located at the back center of each booth space. .
3. Exhibitors are not allowed to share outlets.
4. Electricity is on continually during move in. On show and turned off 30 minutes after show close. If you need power for 24 hours, YOU MUST ORDER 24 HOUR SERVICE.
5. Permanent building utility outlets are not part of your booth space and are not to be used. If services are found to be used which have not been purchased they will be charged at twice the LATE ORDER rate.
6. Exhibitor holds Hollywood Lights Inc harmless for any and all losses of power beyond Hollywood Light's control including but not limited to losses due to utility company failure,permanent power distribution failure, generator failure,power failure caused by vandalism, faulty exhibitor equipment,Exhibitor equipment that's not compatible with GFCI outlets or overloads caused by exhibitor.

7. Outlet rates do not include special wiring of your equipment.
8. All labor is properly insured,supervised,and controlled for the protection of the exhibitor.
9. Hollywood Lights Inc. is not responsible for problems arising from unlabeled mislabeled and the use of non-standard wiring practices on equipment.
